However, I understand that loss of club privileges for any reason does not release me from ice contract or other fee obligations committed to prior to loss of club privileges.

I understand my obligation to fulfill 10 hours per youth skater, of LMFSC volunteer time, throughout the season or pay \$150 by Oct. 1, 2010 to be considered in good standing with USFS.
