Dear LMFSC Member or Prospective Member,

There are **4 forms attached and also a version is available on our Web site:**
www.LMFSC.org for *member application or member renewal*, including:

- (1) *Membership Application/Renewal*
- (2) *Medical Emergency Form (please include a copy of the front and back of your insurance cards)*
- (3) *LMFSC Waiver*
- (4) *Club room Locker forms.*

Please print all forms and return them with the appropriate fees to the Membership Chair (address below). Your membership will not be renewed unless forms are complete with checks enclosed. LMFSC has a 10 hour, per youth skater, volunteer requirement throughout the season or you may pay \$150 by Oct. 1, 2010 to remain in good standing with LMFSC and USFS. You will be receiving your volunteer packet and ice contract information in a separate email. (Collegiate and Starter memberships exempt from the volunteer requirement).

Please write separate checks to LMFSC for membership and lockers and return to MIA attention Membership Chair – Deb Remington

Please note, new members must have two club member endorsements.

It is very important that your membership application be returned/postmarked on/before June 11, 2010. Add a late fee of \$20 if returned after 6/11/10 (Late fee waived for new members). Your membership fee also covers your US Figure Skating membership. LMFSC will register and renew your membership with US Figure Skating upon receipt of your LMFSC membership application. Membership must be current to be eligible to compete or test after July 1, 2010. Your US Figure Skating Membership Card will be mailed at a later date directly from US Figure Skating.

Only 2010-11 LMFSC members will receive preliminary and final ice contracts.

The following membership classifications are available:

Adult: A figure skater who is eighteen (18) years or older. Such members shall have the right to vote and hold office if such persons qualify for nomination. They shall have all club privileges as defined by our club and the Board of Directors. **Annual dues \$95.**

****Youth:** A figure skater who is eighteen (18) years or younger who figure skates as defined by the rules of the USFSA. A parent/guardian of skater may attend membership meetings, serve on committees, and have such privileges and obligations as the Board of Directors may designate. One parent/guardian may hold office if that person qualifies for nomination. One parent/guardian of the family is entitled to one vote at general membership meetings. **Annual dues \$95 (\$72 per additional membership, same family, and if there is more than one skater.)**

Collegiate: A figure skater who is actively enrolled/attending college. This is a one time, 4 consecutive year membership that carries the same privileges as a full member, with the exception of no voting privileges or family volunteer requirement. Spring banquet attendance requires an additional reduced fee. **One time dues \$100.**

Starter: A figure skater, who has not passed any USFS tests, has not passed the ISI Freestyle 3 test and is not participating on a Synchro team. Starter members receive a discounted rate when they join the club for the first/one year only. One parent/guardian of the family is entitled to one vote at general membership meetings. Exempt from the club volunteer requirement. Spring banquet attendance requires an additional fee. **One time dues \$50.**

Coach: A person who coaches LMFSC skater on Club Ice. Coaches must become a member of US Figure Skating through USFS on-line coach's registration. One vote. **Annual dues \$50.**

Patron: A person over 18 years of age who desires to support skating. Registered with US Figure Skating. No vote. **Annual dues \$45.**

Associate: A skater *who belongs to another home club* (and is registered with US Figure Skating through their home club) and wishes to skate on the LMFSC Synchro team and/or purchase LMFSC ice. Associate members are not entitled to vote or normal membership privileges, except each associate member may attend the annual banquet and may be given a club directory. Your current US Figure Skating membership # must be provided on your LMFSC application. **Annual dues \$45.**
